CAPTAIN'S REPORT

I thank the rank and file members of the club who have provided the manpower needed to keep the club working efficiently during this busy season. Generally, most members carried out their duties effectively whilst others had the favourite hiding places. Fortunately, these 'hidiers' are in the minority.

This has been a long, hard season for all when you consider our club has erected a club house, conducted the State and Australian Titles and still has been able to maintain the standard requirements of providing efficient patrols, competing in carnivals and conducting our own weekly swims and training. It only remains that the active member of South Port should receive a pat on the back, because this season he has climaxed the many years of planning and hoping of the founders of the club. South Port is especially known within the movement for having progressive thinkers and workers and it makes one proud to be associated with a club which receives this merit. All that remains is to carry on with our work until we are reputed to be the best, at least in this State, in all facets of lifesaving.

Patrols have been functioning very efficiently, except for the bad habit of some members being a 'few' minutes late. Much of the credit for patrol work must be attributed to Peter Keelan, our Vice Captain, whose planning of the roster left nothing to be desired. Peter spent many hours on patrol and always seemed to be available for a 'fill in' when the need arose, and it must have been gratifying to him when his patrol was successful in winning the Club Patrol Competition.

We thought we were to win the "Wales Patrol Efficiency Trophy" but the final score resulted in our club being third, which I feel was a fair effort by the patrols concerned.

I recommend that the club conduct future club championships on similar lines as we did this season. The advantages to be gained by using basically the Iron Man competition results in less time being required, enjoyable for competitors and entertaining to the spectators. The winner of this season's Club Championship was "Slammer" Simpson who put up a commendable effort.

The most zealous training effort by the 'A' Boat Crew must be commended. I feel that if the season had been an ordinary one the boat crew would have been afforded more time for training, thus more successes may have been gained.

A Rescue and Resuscitation team was formed during the season and they were successful in winning the Branch Title; this was a good effort when considering the little experience the team has had.

I hope the members of both these teams will consent to compete together in the coming season, for I feel with more time being available for training more successes are within their reach.

I thank the members of South Port for allowing me to be their Club Captain for the past season, and assure them of my continued interest in the future.

VICE CAPTAIN'S REPORT

During the 1966-67 Season, the patrolling of our Beach went very smoothly. Our patrol records show only seven rescues, all without gear, and only three of these needing medical attention. This low number of rescues was brought about by the quick action of our Members by:

- (1) Keeping board riders outside of the 'Flags'
- (2) Advising swimmers, particularly children, to swim in the patrolled area.

Only by strict policing of these two main sources of trouble were we able to keep the rescues and casualties to a minimum.

The Casualties, ten during the Season, (six requiring medical attention) were mainly cuts received by swimmers being hit from stray surf boards entering the Patrol Area and cuts to toes and feet from broken glass and tins.

I wish to take this opportunity to thank all Members for the way they have performed their patrol duties. Without this terrific spirit of 'pulling together' our Club would not be one of the smoothest running clubs in the State, for which it is known. Fortunately, the Members who do not pull their weight, not only in patrol duties but in all aspects of club activities, are a very small minority and will be culled out very smartly.

I also wish to thank very sincerely our Reserve Active Members for the great help they have given us, patrol wise, especially on Carnival days when their presence meant that rostered patrol members could go to the Carnivals and compete in the events. These "Old" Members are the backbone on the Club. Thanks again.

During the season we had four WALES PATROL EFFICIENCY COMPETITION inspections. The patrols inspected did an excellent job and only lost

68 points out of a total of 1,600 points. Unfortunately we were not overall winners as we had hoped but came third and won a surf belt for the Club. Better luck next year.

In closing, my thanks to all Members and Committee Members for the friendship and support given to me in the now past Season.

In competition the Club had varied success, at some carnivals showing good potential, and at others only mediocre. This could probably be contributed to the many and varied jobs which the Club had to do, which prevented the more intense training required. Notable performances were at our Branch Championships in winning both March Past and R. & R., with Grantley Anderson taking the beach sprint.

BOAT CAPTAIN'S REPORT

At the beginning of the season South Port had two very important things to consider, the building of a new club house and the running of the Australian National Championships. With these on our minds, the formation of two boat crews seemed difficult if we were going to succeed with all three.

Having decided to commence training early in the season, restoration of the surf boat became an immediate necessity. With the assistance of John Huddy, his employers, Para Motors, were kind enough to make space available to carry out these repairs; for this we thank them. To the few club members who helped with these repairs I extend my sincere appreciation.

Pre-season training commenced early August at North Glenelg, one session per week, increasing to four at the beginning of the season.

The formation of a "B" boat is essential to back up an "A" crew as potential rowers and reserves. During the season in competition they were often placed, which was a very good effort as new rowers were amongst them.

With the entry of Jack Mallee, a very experienced oarsman from way-back, into stroke position the crew was one that had shared between them some 28 years of rowing experience.

In competition the crew gained several placings, which made them eligible for a place in the State Boat Squad to compete for representation in the Australian Titles. Christies Beach were thus honoured, congratulations to them, well deserved.

Our greatest triumph ever was in the Saturday competitions of the Australian National Championships to row into fourth place in the semi-final after winning our heat. This position placed us either 7th or 8th in Australia on the day; in these rows the crew did a tremendous effort. In our heat on Sunday's competition, we repeated our previous year's trick of coming across the finishing line with three other boats and were unfortunate in not being placed.

To the members of that crew, my thanks for your dedication and effort, well done, my thanks also going to the club members for their help and encouragement during the season.
